Graduation with at least 50% marks and 1 year B.Ed. (Special Education).

(ii) Qualified in the Teacher Eligibility Test (TET), conducted by the appropriate Government in accordance with the Guidelines framed by the NCTE for the purpose. i.e. CTET & State TET)

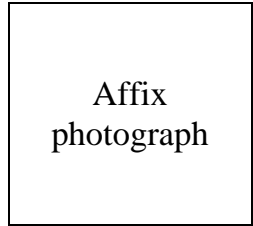
